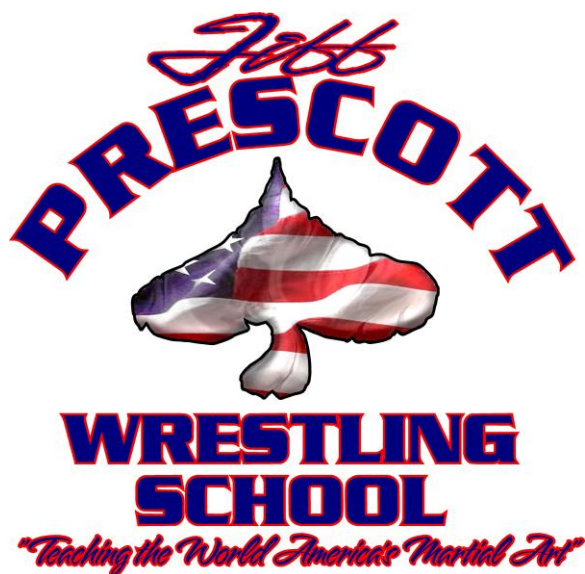

I hereby voluntarily waive any and all claims resulting from ordinary negligence, both present and future, that may be made by me, my family, estate, heirs, or assigns.

Further, I am aware that Prescott Wrestling, LLC activities may range from vigorous cardiovascular activity to strenuous exertion of strength training. The Prescott Wrestling School is a YEAR ROUND wrestling school, sanctioned under USA Wrestling. We do not quit! It's a must to be able to catch up and beat the better wrestler!!! Therefore, all students must obtain a USA wrestling membership card. Go to (themat.com) then click on USA wrestling. Go to memberships and click competitor's membership and make sure to register under Prescott Wrestling School. USA Wrestling charges a one-time fee of \$34.00, which is good for the year. You must submit a copy of your USA card to us for our records and tournaments. If you think that it's expensive, it's not... The School makes way less than minimum wage on each student. If you feel that you can't afford the tuition, you can... Speak with one of our representative for possible solutions. And here's food for thought... Let's say for example, your son is a freshman in high school and you pay a total of 6,480.00 (4years at the Prescott Wrestling School).
